You may register in ONE of THREE (3) ways: FAX the registration form to 229-435-1720 **OR** mail the registration form to Vision Foundation Counseling Center, 1216 Whispering Pines Road, Albany, GA 31707 **OR** call the office at 229-435-1729.

All seminars in **ALBANY** are held at the **Porterfield United Methodist**, 2200 Dawson Road in the Alpha Classroom. Park in the parking lot behind the church. Enter parking lot from Robin Hood Road. Come in the back door. Turn left; second room on the left.

All seminars in **CORDELE** are held at the **Sheriff's Department and Detention Center**, 197 Highway 300 South. Come in front door to first room on the left - Courtroom. From I-75 take Hwy 300 GA/FL Parkway (headed toward Albany). Sheriff's office is about 2 miles on the right. Gray brick building.

All seminars in **TIFTON** are held at the **First United Methodist Church**, 107 12<sup>th</sup> Street West. From I-75 take the Hwy 41/ABAC exit and go toward town. Go to third (3<sup>rd</sup>) light (church is on the left). Park on Central beside the church and come in back door of main part of the church. Seminar is held in Loyalty Room.

The seminar is **court ordered** mandatory for all couples seeking a divorce or change in custody in Georgia that have children 18 years and younger. The seminar is designed to provide information to assist parents in dealing with the effects of the divorce on the children. Couples do **not** have to attend the seminar together. No child care is available at the seminar site. Judges will not grant your divorce final until both parties have attended the seminar. You must **PRE-REGISTER** at least 24 hours before the date/time of the seminar. To pre-register you may call 229-435-1729, **OR** fax registration form to 229-435-1720 **OR** mail the registration form to 1216 Whispering Pines Road, Albany, GA 31707.

When registering you need the name and phone number of person attending, names of the plaintiff and defendant, civil action file number (if it has been assigned) and the date, time and location of the seminar you wish to attend.

**FEE** for the Seminar is \$35. **NO CHECKS !!!** Cash payment due at check-in for the seminar.
